It is further understood and agreed that this contract fully signed, constitutes an order upon the cemetery association to permit Wagner Memorial Co. to remove the memorial work from the cemetery if not fully paid for. Said cemetery association may at any time, without notice, investigation, or explanation, upon demand of the Seller surrender the said monumental work to the Seller. Any action arising out of or in connection with this agreement may be instituted in Macon County, State of Illinois. The Buyers agree to pay a reasonable attorney fee in the event that this contract is not paid at maturity, or in the event that it is placed in the hands of an attorney for collection or in the event that any legal action may arise under this contract. In the event that said Buyer defaults in any of the terms of said contract, or said holder of said contract deems himself insecure, he has the right to declare the full amount then due and owing on said contract payable at once and without notice. This contract shall bind the heirs, executors, successors and assigns of the parties thereto. Upon failure by the purchaser to comply with the provisions hereof, he waives all claims against the Seller and in such case the Seller may institute action for the purchase price without delivery of said property.
